

## **Alliance Agreement**

This Strategic Alliance Agreement (this "Agreement") was entered on January 27, 2021, by and between the United Military State of the Moon and the Free State of Florensia.

### **WITNESSETH:**

**WHEREAS**, the United Military State of the Moon and the Free State of Florensia wish to enter an alliance to recognize the other, agree to stay allies and not enemies, and give each other the right to embassies.

**NOW, THEREFORE**, in consideration of the foregoing and of the mutual premises hereinafter expressed, the parties hereto do mutually agree as follows:

### **1. SCOPE OF THE ALLIANCE**

Supreme Leader Iain Turnbull and Supreme Archon Frederick Yoon shall, in a professional manner, take all steps necessary to market and perform its business, while supporting each other along the way if needed. Signing this document that: Supreme Leader Iain Turnbull and the United Military States of the Moon shall recognize the sovereignty of the Free State of Florensia, and Supreme Archon Frederick Yoon and the Free State of Florensia shall recognize the sovereignty of the United Military States of the Moon. Furthermore, the signing of this treaty connotes that all signatories and affiliated parties are under the agreement to stay allies and not become enemies unless the treaty is voided. In addition to this, the signing of this treaty connotes that all signatories and affiliated parties are under the agreement to give the opposite party the right to an embassy, whether virtual or physical in the relevant parties' affiliated territories.

### **2. PERIOD OF PERFORMANCE**

This Agreement shall be effective as of the date first set forth above and shall continue indefinitely. Notwithstanding the foregoing, this Agreement shall be earlier terminated by mutual agreement of the parties. Time is of the essence in this Agreement.

### **3. ENTIRE AGREEMENT**

This Agreement together with all documents incorporated by reference herein constitutes the entire and sole agreement between the parties with respect to the subject matter hereof and supersedes any prior agreements, negotiations, understandings, or other matters, whether oral or written, with respect to the subject matter hereof. This Agreement cannot be modified, changed, or amended, except for in writing signed by an authorized representative of each of the parties.

#### **4. CONFLICT**

In the event of any conflict, ambiguity, or inconsistency between this Agreement and any other document which may be annexed hereto, the terms of this Agreement shall govern.

#### **5. ASSIGNMENT AND DELEGATION**

Neither party shall assign or delegate this Agreement or any rights, duties, or obligations hereunder to any other person and/or entity without prior express written approval of the other party.
